**Schedule B to By-law No. 2008-20**

**Sewage Treatment Plant Upgrade**

**Local Improvement Plan – (LID #9) –No. 2008-01**

**Pursuant to Section 315 of *The Municipal Act***

**A. Description of the proposed Local Improvement:**

The RM of East St. Paul must upgrade their current sewage treatment plant to include new environmental requirements under Manitoba Conservation and recommendations of the Lake Winnipeg Stewardship Board. A new ultraviolet disinfection systems facility to replace the use of chlorine will be established while biological phosphorus removal will also be incorporated at the sewage treatment plant. The total cost of the upgrade project is estimated at \$1,300,000.00. The RM of East St. Paul Sewage Treatment Plant will also be expanded at a cost of \$3,300,000.00 in conjunction with the required upgrade. This portion of the project costs will be paid from the Sewer Utility Reserve Fund and the Gas Tax Reserve Fund. A copy of the "Opinion of Probable Construction Cost" dated March 20, 2008 and prepared by Stantec Consulting Ltd. is attached for information. Appendix 1

**B. Identification of the local improvement district (LID #9):**

The local improvement district will include all properties in the municipality other than property described in section 21 of *The Municipal Assessment Act* which are connected to the RM of East St. Paul sewage system.

**C. Identification of the potential taxpayers:**

The potential taxpayers will be the property owners of all taxable, grant-in-lieu and otherwise exempt properties in the municipality which are connected to the RM of East St. Paul sewage system and are described in Schedule "C".

**D. Method and Rate for calculation of the proposed local improvement tax:**

The method to be used for calculating the proposed local improvement tax will be based on an amount for each parcel of land on property that is real property, described in Schedule "C". The rate will be:

Finance cost - \$73.80 per annum (based on one (1) residential unit equivalent (REU) for the years 2009 to 2018

Pursuant to section 325 of The Municipal Act, all taxpayers will be offered the option to pre-pay their portion of the local improvement tax by the above noted date.

**E. Estimated Cost:**

The total estimated cost of the local improvement is \$1,300,000.00 allocated to the upgrade and \$550,907.58 interest over the ten (10) year repayment period for a total of \$1,850,907.58.

**F. Source of funding:**

The total cost of the local improvement is \$1,300,000.00 and will be solely borne by potential property owners.

**G. Estimated amount of money to be borrowed:**

Amount: \$1,300,000.00

Maximum rate: 7% interest

Term: ten (10) year term

Annual payment: \$185,090.75

**H. Annual funding:**

The annual operation or maintenance of the local improvement will be funded through revenues received from the quarterly levy charged to customers of the sewer utility.
